

WETWALL 10 YEAR LIMITED WARRANTY

WHAT IS COVERED:

Wilsonart LLC (“Wilsonart”) warrants that the Wetwall Wall Panel Systems (“Wetwall”) will be free from defects in material during normal residential use and service for ten (10) years from the date of sale (“Warranty Period”). If Wetwall products are installed outside of the United States of America, Canada, or Mexico or used commercially, Wilsonart warrants that Wetwall will be free from defects in material for three (3) years from the date of sale (“Warranty Period”). To activate this limited warranty, the original consumer purchaser must go online to <https://warranty.wetwall.com> to register their Wetwall Wall Panel System within thirty (30) days of purchase.

WHAT IS EXCLUDED:

Wilsonart is not responsible for labor charges, installation, other incidental or consequential costs, or the cost of repair or replacement of any installation materials including but not limited to tile(s), marble etc. In no event shall the liability of Wilsonart exceed the purchase price of the Wetwall product. Damages due to improper handling, installation or maintenance are not considered manufacturing defects and are not covered by this warranty. This warranty is valid for the original, consumer purchaser only. Proof of purchase (original sales receipt) must be provided to Wilsonart with all warranty claims.

This warranty shall not apply to damage arising from any of the following:

1. Accidents, abuse or misuse;
2. Exposure to extreme temperature changes;
3. Exposure to harsh or corrosive chemicals and cleaners;
4. Excessive weight placed on or against wall panel;
5. Structural support or movement;
6. Improperly installed, used and/or maintained appliances, fixtures, or accessories;
7. Acts of nature;
8. Failure to use or maintain the product in accordance with Wetwall’s published Care and Maintenance Guidelines (see www.wetwall.com or information supplied to Wetwall’s distributors and retailers)
